A/A:

On 10-5-08, While assigned as 1B856, Sent via Dispatch to an possible fight call. The case was later reclassified to an ICF type of case, reported at about 0001 hours.

TIME/ SCENE:

The time element was sometime earlier than reported time of 0001 hours on 10-05-08. The scene was in ██████'s residence at ██████ Kakaiapola Street.

OBSERVATIONS:

Upon arrival, I observed a hysterical female carrying an infant in the street fronting the residence. Ambulance personnel was able to take control of the infant and began medical attention. The female carrying the infant was observed to be bleeding from several puncture wounds to her right leg near her knee. She uttered " I can't believe my aunty would leave him by himself." The female was later identified as the child's mother, ██████. The infant was later identified as ██████.

INJURIES/ TREATMENT:

The infant had head injuries, related to be from a dog bite. He was treated by Paramedic ██████ and transported to Queens in serious condition.

The mother ██████ had puncture wounds to her outer right knee area, also treated and transported in the same ambulance to Queens Hospital.

OTHER HOME OCCUPANTS:

(1)There were two other females at the residence at the time of the dog bite. The female verbally identified herself as, ██████. She related that she did not witness the bite, only when the infant was found. Refer to Face Page for information. No HPD-252 taken due to emotional state of ██████.

(2)The other female verbally identified herself as ██████, and was not able to give a statement due to emotional state. Refer to Face Page for information.

(3)The last person to see the infant prior to the dog bite verbally identified herself as ██████. She also was not able to give a statement due to emotional state. Refer to Face Page for information.

SUSPECTED DOG:

Per females the dog that bit both ██████ and ██████ is a black Sharpei/ Pitbull mix, and was secured in a chain kennel in the yard. Related that the dogs name is "██████" and she is about 4 years old.

██████ related that ██████ was brought in as a house dog one month prior to incident, but was not allowed on the bed.

SCENE OF BITE:

In the rear bedroom of the residence, observed a pool of blood and matter on the comforter, and blood drips in the hallway.
