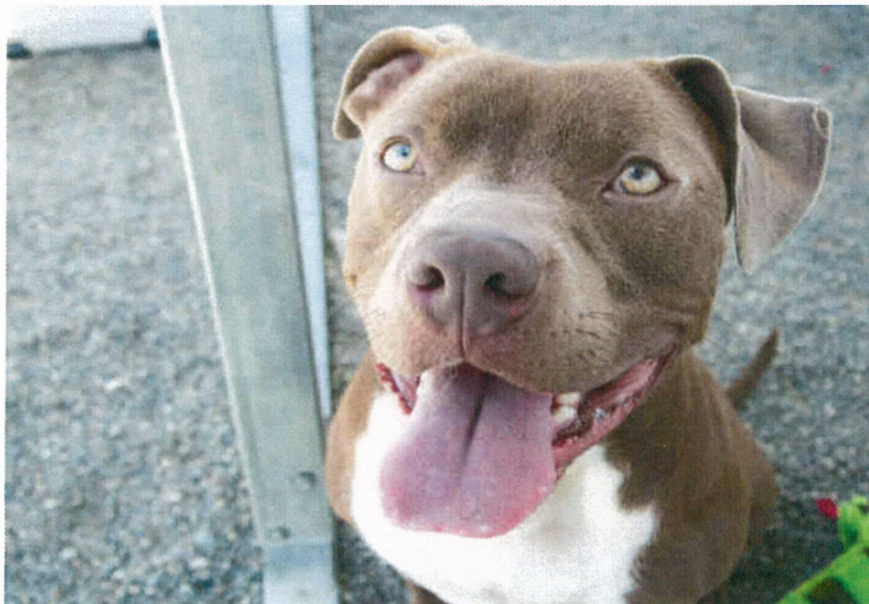

I went to take Arnie out of his kennel and fit him with a Gentle Leader and did not connect the leash to it. The leash was connected to his collar but he should have a harness as well. I walked him through the Stray kennels, and out the Sally Port with no leash tugging or jumping up. As we started to go for a walk out in the parking lot, he turned to look towards the leash and acted like he wanted grab the leash so I fed him the rope tug into his mouth instead. He began to play tug as he walked to release his excitement about going for a walk. I encouraged him to continue to pull on the rope toy instead of the leash. He would carry it in his mouth and drop it once in a while. As long as he did not tug on the leash then he was rewarded. He walked the entire parking lot and down the drive way with no pulling on the leash. He will learn that this is how he walks on the leash. He can release his arousal on the tug rope while he learns to walk on leash without tugging. I spoke with [REDACTED] about how they are to walk him and the exercises that they are to do with him. At the end I decided that part of his jumping up was attention seeking behavior with [REDACTED] so we had him sit then lay down and gave him a massage. He leaned on us at times sitting and just could not get close enough. He was so calm for about 10 minutes. Then we walked past his rope tug and he sniffed it and walked on. As we walked by, I reached down and grabbed the rope and put it behind my back in case I needed it. I think if he disregards it regularly you can go ahead and keep walking without picking it up and just do find its if he jumps up. We walked all the way through the kennels with no leash tugging or rope toy in his mouth. He was amazing. I think getting him to have some time to just be quiet and calm with people is key. He is such a quick and happy learner. I wish I could spend more time-I think he just needs a job. He was a little focused on the leash on the way back into the kennels but the tug toy eased our transition.
