Summary: The decedent was a 59 year old female who was employed as a letter carrier by the USPS. While on her normal route in the city of Escondido on the afternoon of 03/01/12, she was bitten by a dog on both her legs. 9-1-1 was called to the scene and while being assessed by emergency personnel, she developed slurred speech and became unresponsive. She was transported to Palomar Medical Center where she was diagnosed with an intracerebral hemorrhage. She was admitted with a poor prognosis and on the afternoon of 03/03/12, she was removed from life support. On the evening of 03/04/12, she became pulseless and her death was pronounced.
