CHILD BEING ATTACKED, BY TWO PIT BULL DOGS, WHICH IS LOCATED OFF OF UNION GROVE RD. UPON MY ARRIVAL I LOCATED THE VICTIM, MS. ERIN INGRAM, LYING IN THE MIDDLE OF THE STREET BLEEDING PROFUSELY ALL OVER HER BODY.

SGT. R. PEELER #2121 WAS THE FIRST RESPONDER TO THE SCENE. HE STATED THAT THE ATTACK WAS STILL ACTIVE ON THE VICTIM UPON HIS ARRIVAL. HE STATED HE STRUCK BOTH PIT-BULLS WITH HIS ASP BATON, AND THEY LET GO OF THE VICTIM. ONE OF THE PIT-BULLS ATTEMPTED TO ATTACK HIM, AND HE HAD TO FIRE ONE ROUND FROM HIS BERETTA 92G DUTY WEAPON TO PREVENT THE DOG FROM FURTHER ATTACK. THE OTHER PIT BULL RAN DOWN THE STREET TOWARDS THE CULDESAC.

RESCUE 13 AND ENGINE 14 ARRIVED ON SCENE TO TREAT THE VICTIM FOR HER INJURIES. SHE WAS IMMEDIATELY TRANSPORTED TO EGLESTON CHILDREN'S HOSPITAL BY RESCUE 13. THE CRIME SCENE WAS ESTABLISHED AND SECURED WITH CRIME SCENE TAPE.

THE WITNESS, MS. GLENDA POYTHRESS, STATED SHE WAS DRIVING INTO THE SUBDIVISION, WHEN SHE NOTICED THE DOGS ATTACKING THE VICTIM. SHE CALLED DEKALB COUNTY 911, AND STARTED TO HONK HER HORN IN ATTEMPT TO SCARE THE ANIMALS AWAY. THE VICTIM'S SISTER, MS. NISHA HUDSON, THEN EXITED HER RESIDENCE, AND WITNESSED THE ATTACK ON HER SISTER.

THE SECOND WITNESS, MS. LISA VINING, STATED SHE ATTEMPTED TO STRIKE THE ANIMALS WITH HER UMBRELLA, BUT THEY WOULD NOT STOP THE ATTACK. SHE ALSO STATED SHE TOOK A PICTURE ON HER CAMERA PHONE OF THE ATTACK. SHE ATTEMPTED TO PICTURE TEXT THE IMAGE TO MY PHONE, HOWEVER IT WAS UNSUCCESSFUL.

THROUGH STATEMENTS OF THE NEIGHBORS, IT WAS DETERMINED THAT THE ANIMALS RESIDED AT 2244 MARGARET CT. THAT WAS ALSO THE SAME DIRECTION THAT THE LOOSE PIT BULL HAD RAN AFTER THE FIRST DOG WAS SHOT. THE SECOND ANIMAL WAS CAPTURED INSIDE THE GARAGE BY THE CRIME SUPPRESSION TEAM, AND ANIMAL CONTROL OFC. CHANDLER #1567, AND OFC. BEAM #9033.

THE OWNER OF THE ANIMALS WAS NOT AT HER RESIDENCE AT THE TIME OF THE ATTACK. THE GARAGE DOOR HAD BEEN LEFT OPEN, AND APPARENTLY THE TWO PIT BULL ANIMALS WERE INSIDE THE GARAGE. THERE WERE NO LEASHES, ROPES, FENCES, OR ANY RESTRAINTS THAT WOULD HAVE PREVENTED THE ANIMALS FROM WALKING FREELY THROUGHOUT THE AREA.

ONE NEIGHBOR ADVISED THAT THEY SAW THE OWNER PULL INTO THE TOP OF MARGARET CT. IN A U-HAUL TRUCK, AND THEN TURN AROUND AND DRIVE AWAY. THE CRIME SUPPRESSION TEAM SURROUNDED THE AREA ATTEMPTING TO LOCATE THE OWNER OF THE DOGS.

INTERNAL AFFAIRS WAS CONTACTED AND RESPONDED TO THE SCENE.

I ARRIVED AT EGLESTON CHILDREN'S HOSPITAL AT 1746 HRS. THE VICTIM, MS. ERIN INGRAM, WAS LOCATED IN TRAUMA ROOM 4. PUBLIC SAFETY DIRECTOR. WILLIAM MILLER WAS ALSO PRESENT AT THE HOSPITAL.

I SPOKE WITH THE VICTIM'S FATHER, MR. TOMMIE INGRAM, AND INFORMED HIM OF THE SITUATION. I ALSO INFORMED HIM THE FACTS THAT I KNEW OF THE INCIDENT, AND LEFT A CASE NUMBER IN REFERENCE TO THIS INCIDENT WITH HIS FAMILY.

AT 1913 HRS. I WAS INFORMED THAT THE U-HAUL TRUCK HAD BEEN LOCATED AT 7980 EROLL DR. OFC. W. HOGAN #2805 AND ANIMAL CONTROL OFC. CHANDLER #1567 ASKED THE HOMEOWNER, MS. DAVIS, IF THEY COULD STEP IN TO ATTEMPT TO LOCATE THE DOG'S OWNER(SUSPECT- MS. TWYANN VAUGHN). THE SUSPECT WAS LOCATED IN THE KITCHEN. AND SHE WAS DETAINED WITHOUT INCIDENT.

FURTHER INVESTIGATION AND CRIMINAL PROCEEDINGS WILL BE HANDLED BY THE DEKALB COUNTY ANIMAL CONTROL DEPARTMENT.
