NARRATIVE#1

On 01-23-2013, at approximately 1818, received a call from a concerned citizen about a dog being loose and also another dog not able to get water and shelter. I arrived along with Capt. Sayer and Cpl. Ankerich at approximately 1850 and saw that a black dog coming from the porch area that didn't have a leash. I knocked on the door several times and got no answer. We then went to the back yard area to see if we could locate the other dog. I saw with the aid of the flashlight another dog that appeared to have it's tether hooked on debris and vegetation that prevented it from going to it's dog house and also from getting water. The local temperature in the area at night had been reaching below freezing.

I was able to free the dog as it went on to drink water. While removing other debris the owner of the residence came outside after being notified by a neighbor that we were outside. Capt. Sayer told me as I came to the front of the house, that the owner was going inside to get identification and also that he had taken a couple of pictures of the dogs.

The owner whom was identified as Sandra Bowers Adams said that she was in the back area of the house and didn't hear me knocking and also she had let the dog outside unsupervised approximately a half hour ago so the dog could use the bathroom while she was inside. Adams was explained th5e city ordinance of the leash law and also how we had untangled the other dog from the debris in the back yard+'. Adams was issued a city citation #C32723 for violation of the leash law along with Capt. Sayer saying that he had seen the dog wandering in the street unsupervised on several occasions. He just didn't know that the dog belonged to her.

Adams received assigned court date of 03-11-2013 and copy of the citation.

SUPPLEMENT #2

On Wednesday January 23, 2013 at approximately 1820 this officer arrived at South Forest Avenue due to a report of a dog at large and a second dog being tangled up and unable to get to its food and water.

Upon arrival this officer observed Cpl. Starks was knocking on the front door and Cpl. Ankerich standing to the side of her patrol vehicle in the driveway. This officer also observed a black dog which resembled a black Labrador retriever which was free and walking around within the yard. This officer took a photo of the dog as Cpl. Starks freed the tangled up dog.

Sandra Adams come up to the officer and asked if she could help us. This officer explained to her that we had received a call in reference to her dog roaming around and another dog not being able to get to its water.

Ms. Adams asked if we espond to all calls like this and this officer advised yes, and that this officer had written search warrants to be able to retrieve the neglected dogs. Ms. Adams then requested to know who called and she was advised that this officer did not know. But were received a call and witnessed was reported.

Ms. Adams stated that she had just let the black dog out and that he had only been out thirty minutes and he never left the yard. This officer advised her that this officer had seen her dog in the road as well as in the area but did not know it was her dog. Cpl. Starks issued a citation and



On December 25, 2015 this officer was at the residence of talking with him and his friend, about a dog that had acted aggressive toward them. This officer had issued the owner (Ms. Sandra Adams) a citation for allowing the dog to run loose in the neighborhood.

During this conversation with an and an action both expressed a great concern about this white pit buildog because every time it gets loose and runs the neighborhood it will pick at least someone out and act aggressive toward them. Both advised that there are several neighbors who have called in their concerns about this dog.

This officer advised aggressive and advised them that I would check with this agency's records for information.

As indicated above with the references, during 2013, 2014 and 2015 there have been six reports written including this one addressing Ms. Sandra Adams. Ms. Sandra Adams has been issued three warnings and three citations. The last three reports listed above appear to deal with this white pit buildog. This officer checked only under Ms. Sandra Adams and did not check under who is her daughter. Under the most recent ordinances of 6-71 and 6-75 it appears that this white pit buildog can be declared a nuisance If this is the same white pit buildog in previous incidents. The Adams' residence has a history of keeping dogs, mostly pit buildogs and white dogs seem to be a favorite.

This officer sent an Email to the attention of the clerk of court about this matter.
